### SHOW GUIDELINES

- 1 A \$30 fee will be assessed for all returned checks.
- 2 Service animals are permitted at the RP Funding Center.
- 3 **NO** outside food vendors are permitted at the RP Funding Center without prior approval.
- 4 Move-in will take place Thursday, July 14<sup>th</sup>, 9 am - 5 pm. Upon arrival at the RP Funding Center, Fancy Flea Staff will provide you with your vendor packet and direct you where to unload. During load in/out you may park behind the RP Funding Center (as long as there is proper space). Once unloaded, move your vehicle to the designated area in the Red Lot. If you do not need the actual loading dock to unload your items, you may park behind the RP Funding Center to walk your items in and then move your vehicle to the Red Lot. Hand trucks and dollies are available on a first-come/first-served basis. **DO NOT ABANDON YOUR VEHICLE AFTER UNLOADING. IF YOU DO, YOU WILL HAVE TO UNLOAD FROM THE RED LOT AT THE NEXT SHOW!**
- 5 Booths must be open and staffed during the show at all times. Vendors must keep their areas clean and neat during market hours, including final clean up at the end of the day Friday and Saturday. **The Fancy Flea Vintage Home & Garden Market, LLC** will not be responsible for refunds or any liabilities for the failure to fulfill this contract due to the location of the show being destroyed by fire or other calamity, or by any Act of God, public enemy, strikes, ordinances, or any legal authority, or any cause beyond its control. **Show is held rain or shine. No refunds for cancellations 60 days prior to the show date.**
- 6 Vendors shall be liable for delivery, handling, erection/removal of their display and materials. Vendors found in violation of these rules may be excluded from future shows at management's sole discretion. No refunds will be provided. Under no circumstances (including negligence) shall **The Fancy Flea Vintage Home & Garden Market, LLC** be liable for any direct, indirect, incidental, special or consequential damages resulting from such action. All tents used at the show must carry fire retardant certificate.
- 7 This agreement constitutes a contract between **The Fancy Flea Vintage Home & Garden Market, LLC** and the vendor and modifications are invalid unless in writing and approved by show management.
- 8 Failure to follow these rules or exhibiting crude or abusive behavior will result in termination of your involvement in future shows.
